2022 LEGISLATIVE SESSION BEGINS

The 2022 Legislative Session began Wednesday, January 12th. Because he was battling COVID, Governor Justice was unable to give his State of the State Address in person. His written remarks expressed his optimism regarding West Virginia's future. The Governor proposed a relatively flat budget, including pay raises for state employees.

There have been 458 bills introduced in the Senate and 925 bills introduced in the House of Delegates. Many of these bills are carryover bills from the 2021 Session.

As a sign of the times, much of this week has been spent on COVID mandates. House Bill 4071, a bill that would ban mask mandates in West Virginia schools, is still in its early stages. but has advanced out of House Education Committee. 35 school districts require masks, while 12 refer to the county alert map for guidance. Masks are optional in only one county -Pocahontas. The West Virginia DHHR is reporting all but two counties in the Kanawha Valley currently red on the map. The CDC is still recommending universal indoor masking in schools. The bill has not reached the house or senate floors yet. Its next stop is the House Judiciary Committee. Other bills addressing COVID and mask mandates include SB 23, HB 4298, HB 4080 and HB 2869.

Legislators heard from WVU Economist John Deskins this week that financial recovery is swifter than expected.

General Business

HB 3267 Relating to inventory tax reduction. The purpose of this bill is to change the method of assessing inventory for taxing purposes.

HB 3115 Guarantee Earned Sick Days for every worker. The purpose of this bill is to establish minimum requirements and protections for earned paid sick leave for all workers in this state.

HB 2710 Providing counties the power to establish a county sales tax under certain circumstances. The purpose of this bill is to allow counties that contain municipalities with a home rule sales tax to also enact a sales tax equal to that of the municipality.

HB 2866 Establishing the Municipal Home Rule Program. The purpose of this bill is to remove the authority of municipalities participating in the Municipal Home Rule Program to impose a municipal sales tax.

SB 132 Requiring municipalities impose one percent sales tax must reduce and remove B&O tax in five years. The purpose of this bill is to require a municipality to eliminate its business and occupation tax within five years of instituting a one percent sales tax.

SB 457 Relating to reducing consumers sales and service tax. The purpose of this bill is to reduce the consumer sales and service tax from six percent to five percent as well as establish a process which continues to gradually reduce the consumer sales and service tax every time the combined balance of the Rainy Day Fund reaches \$1,100,000,000.

Following are bills specific to our industry:

<u>HB 2170 Unfair Trade Practices.</u> The purpose of this bill is to prohibit the use of a person's credit history in certain insurance transactions involving passenger motor vehicles or commercial vehicle insurance lines.

SB 89 Relating to surcharge on fire and casualty insurance policies for funding volunteer fire departments. The purpose of this bill is to restore to one percent the surcharge on fire and casualty insurance policies to fund volunteer fire departments. Obsolete language is removed.

SB 234 Creating surcharge on fire and casualty insurance policies to help municipalities and counties with certain fire-related cleanup and demolition. This legislation would provide:

(a) For the purpose of providing funds for municipalities and counties that are left to pay for demolition and cleanup following a fire at privately owned property that does not have sufficient insurance, does not have insurance or where an insurance policy has lapsed, there is hereby authorized and imposed on the policyholder of every fire insurance policy or casualty insurance policy issued by any insurer, authorized or unauthorized, or by any risk retention group, a policy surcharge equal to one tenth of one percent of the taxable premium for each such policy. This surcharge is in addition to other similar surcharges and taxes currently existing in law.

2022 LEGISLATIVE CALENDAR



First Day - January 12, 2022: First day of session.

Twentieth Day - January 31, 2022: Submission of Legislative Rule-Making Review bills due.

Thirty-fifth Day - February 15, 2022: Last day to introduce bills in the House.

Forty-first Day - February 21, 2022: Last day to introduce bills

in the Senate.

Forty-seventh Day - February 27, 2022: Bills due out of committees in house of origin to ensure three full days for readings.

Fiftieth Day - March 2, 2022: Last day to consider bill on third reading in house of origin. Does not include budget or supplementary appropriation bills.

Sixtieth Day - March 12, 2022: Adjournment at Midnight.
